Exhibitors and Traders **MUST** comply with the Safety Code in operation at the Event Site. The speed limit in Markeaton Park is **5 MPH** at all times. No vehicle movements are allowed within the Event Site between 10:00am and 16:00pm without good reason and must be supervised by Event Stewards. A charge will be made for electrical hook up to cover fuel and other charges of £10 (per user), connection will be refused if your equipment is deemed dangerous or excessive. Connection is at users risk. In any dispute the decision of the Safety Officer shall be final. Infringements of the Safety Code may result in the Exhibit or trade vehicles / equipment being prohibited from the Event Site. **Please see the web site for details of facilities available to you at the event.**

You as the Trader are responsible for all members of the group of people that accompany you. **You** must ensure that you and they are competent and capable to undertake their part in any displays you / they are involved with. Drivers of vehicles must be licensed and insured for the vehicle they are driving.

Traders **MUST** have their own Public Liability Insurance for this type of event, covering all members of their party / staff, having a minimum indemnity of £2,000,000. A copy of your Insurance certificate must be forwarded with this entry form and carried at the event. Failure to produce a valid certificate will result in the Exhibit or trade vehicles/equipment being prohibited from the Event Site. Remember the FSPG insurance covers its members at these events.

I HAVE READ AND AGREE TO ABIDE BY, AND COMPLY WITH THE ABOVE CONDITIONS AND TO ACT ON THE INSTRUCTIONS OF THE STEWARDS AT ALL TIMES. I DECLARE that during the period of the Event my entry / company will be covered by Public Liability Insurance of not less than £2,000,000. In default of this declaration I agree to indemnify and hold harmless the Organisers of the Event, its Officers and Helpers or any other person acting on their instruction or behalf from any claim for accidental damage or personal injury whatsoever, or death, howsoever caused by my entry and participation in this Event. I FURTHER DECLARE that if I use the exhibit on the public highway, the exhibit is covered by a valid insurance and relevant road tax as required by the Road Traffic Act 1960 and is fit for use on the highway as defined in the act.
